Mr. Vicente Fernández Guerrero



He was born in Malaga in 1973, although he has resided most of his life in Cadiz and Seville. After finishing his secondary studies in Cadiz, he earned a degree in Law in the University of Seville in 1996. Later, in 1999, he passed the Civil Service exam for becoming a member of the Corps of State Lawyers for the regional Government of Andalusia, being the number one that year. Since then he has carried out public functions and positions regarding advice, management and control of public expenditure.

While being in active service, he headed the legal counsels of a number of departments of the regional Government of Andalusia: Tourism and Sports; Education and Science; Economy and Finance; Innovation, Science and Employment. Equally, he headed the legal counsel of the Andalusian Tax Agency, being appointed afterwards Head for Consultative Issues at the Legal Office of the regional Government of Andalusia.

He has also fulfilled the position of Secretary in a number of Boards of Directors in state-owned companies, such as the Empresa Pública de Gestión de Activos (state-

owned company for assets management), of the Sociedad de Gestión (management company), Financiación e Inversión Patrimonial (Patrimonial financing and investing), or of Cartuja 93.

From 2012 to 2016 he was Secretary-General for Innovation, Industry and Energy, and Chairman of the Andalusian Agency for Energy (AAE), of Andalusian Industrial Verifications (VEIASA), of the Andalusian Company for the Promotion of Telecommunications (SANDETEL) and of AEROPOLIS, the only European Science and Technological Park exclusively dedicated to the aerospace industry.

Since February 2016, he was General Comptroller of the regional Government of Andalusia, the highest body for the internal control and public accounting of the financial management of the Andalusian Administration and of the totality of its instrumental entities.

Functions

1- He chairs the Spanish state-owned industrial holding company Sociedad Estatal de Participaciones Industriales (SEPI), an entity attached to the Ministry of Finance through the Minister.

In that capacity, he:

- a) Represents on a permanent basis SEPI and its Board of Directors in any action or contract, and versus any natural or legal person.
- b) Summons, chairs and raises the meetings of the Board of Directors, leading its deliberations.
- c) Approves certain SEPI's contracts, in keeping with the limits set by the Board of Directors.
- d) Leads SEPI's services and controls its activity.
- e) Makes sure that that stipulated in the Order on July 13th, 1995 from the Ministry of Industry and Energy regarding SEPI's organization and functions is observed, and for the implementation of the resolutions taken by the Board of Directors.
- f) Submits to the Board of Directors the operating and capital budgets, as well as SEPI's operating, investment, and financing programs and, when appropriate, those of the companies which are attached to it.
- g) Decides about expenditure and gives orders about the corresponding payments.
- h) Exercises the powers which have been delegated by the Board of Directors.
- 2- In his capacity of SEPI's Chairman, he chairs over the Board of Trustees of Fundación SEPI.
